1) Letter of Application

Please enclose a letter with your application describing your educational objectives, the reasons you selected these objectives and the progress you are making.

2) Proof of Enrollment or Letter of Acceptance to a College, University or Seminary.

Please send a copy of your acceptance letter from your institution or a letter from your institution stating that you are enrolled as a full time student for the 2110-2011 school year.

3) Official Transcripts

Please arrange with the school registrar of the post secondary institution you are attending to have an original copy of your current transcript mailed to the Georgetown Tribal Council Office. Georgetown will not accept copies of transcripts. If you do not have post secondary education transcripts because you have just enrolled to school, please have your high school send a copy of official transcript.

4) Copy of Lease Agreement

Please send a copy of your lease agreement for the apartment you are renting while you are attending school. If you are not renting an apartment, send a copy of the agreement for the residence you will be occupying (i.e., dormitory, room, etc.). The lease must be signed by both you and the lessor (landlord or owner), must show the amount of rent you pay for rent each month and the dates of the lease must correspond with the dates you are enrolled in school.

5) Copy of 2009 Tax Return

Please send a copy of your 2009 tax return to verify your eligibility for award.

All of the above information and a completed signed application must be returned to Georgetown Tribal Council on January 21, 2010 by 5:00 pm to be considered for award.
